ASC Leadership in Action – Senior Nutrition

With severe budget cuts proposed by the City of San Jose last March, the Senior Nutrition program in San Jose was placed in jeopardy. Members of the ASC Executive Committee joined forces with other advocates and elected officials to convey the impact of these cuts and advocate for alternative solutions. They sponsored several activities including:

- **Senior Nutrition Briefing** for elected officials with 52 in attendance
- Stand Up for Seniors Day of Action over 100 in attendance with 6 speakers
- Media coverage of the issue including an Op Ed in the Mercury News
- Formation of a **Senior Nutrition Task Force**

In addition to the core members of the ASC Executive Committee – Council on Aging, Health Trust, County Department of Aging & Adult Services and the City of San Jose, many others partnered on these efforts. We want to especially thank Pete Constant, City of San Jose Council Member, Liz Kniss, Board of Supervisors, Patricia Gardner, Silicon Valley Council on Nonprofits, City and County Senior Commissions and the many individuals who organized to participate in the Stand Up for Seniors Day of Action.

As many of you know, the City of San Jose passed their final budget in late June and we are thankful that the Mayor and Council gave the senior nutrition program a reprieve for at least one year. The current sites will remain open this year but their long term future is still in guestion.

To this end, thanks to Councilmember Pete Constant, a Senior Nutrition Task Force was launched with Pete co-chairing with Liz Kniss, County Supervisor. The task force will seek a long term solution to keep the senior nutrition program strong and solvent.
